

MUESTRA DE CINE DE LANZAROTE 2018
**CONDITIONS FOR PARTICIPATION IN COMPETITION FOR FEATURE-
LENGTH FILMS**

The goal of the **Muestra de Cine de Lanzarote** is to promote, disseminate and exhibit independent films, and to this end it organises a competition of feature-length films which will be included in the *Official Section of the 8th Muestra de Cine de Lanzarote*, to be held from 23 November to 1 December 2018.

CONDITIONS

1. The competition (*Official Section of the 8th Muestra de Cine de Lanzarote*) shall have one single category open to fiction and non-fiction feature-length films from any country or nationality.

For the purposes of this competition, a feature-length film is any film with a duration of 40 minutes or more.

2. All entries shall be produced after 1 January 2017 and shall not have been distributed commercially in film theatres or in home-cinema supports (Blu-ray, DVD or Internet) in Spain.

3. There shall be one single prize (*Best Film at Official Section of the 8th Muestra de Cine de Lanzarote*) whose winner shall receive 2500 euros and a statuette, and the prize shall not be declared void. The prize money shall be subject to tax deductions legally in force at the time of payment, and said deductions are included within the prize money.

4. The Muestra de Cine de Lanzarote shall conserve a copy of the prize-winning film for its archives, and may exhibit it once within its annual programme with a not-for-profit cultural purpose.

5. The Organisation of the Muestra de Cine de Lanzarote shall appoint a jury with a minimum of three members and a maximum of five members, whose decision is final. Members of the jury shall not have any interests in the production, distribution or any form of exploitation of the films selected for the competition.

6. The Director and/or a representative of the Muestra de Cine de Lanzarote may be present during the deliberations of the jury, having the right to speak but not to vote.

7. The prize-winning film shall include the logotype of the Muestra de Cine de Lanzarote in the opening credits of each copy of the film exhibited following the conclusion of the festival, both in copies for commercial film theatres as well as copies for home-cinema supports (Blu-ray, DVD or Internet), as well as in any kind of material used to promote the film.

8. The prize money shall be paid following the signing of an agreement between the organisation of the festival and the producers of the prize-winning film, which specifies the terms of the fulfilment of point 7 of these conditions.

9. To enter films for the competition, the producers or distributors shall upload them onto the Festhome platform or send a private link (with password) to the following address: info@muestradecinedelanzarote.com. In either case, films must be accompanied by the corresponding fact sheet. All films must be sent with subtitles in Spanish or in English.

10. The period for entering films in the competition begins on 1 June and concludes on 15 September 2018.

11. During the Muestra de Cine de Lanzarote the organisation may exhibit the selected films on a maximum of two occasions, with the exception of the prize-winning film, which may be exhibited on three occasions. For this purpose, the producers shall cede the rights for the public exhibition of the films for the duration of the festival, without any cost.

12. For the purposes of screening, all films selected for the competition must be presented as DCP or digital archives together with a copy in BLU-RAY format (as a back-up copy).

13. The costs of sending copies of films to the Muestra de Cine de Lanzarote (transport and insurance) shall be paid by the producers. All copies of the films selected for the competition shall include a return address. The cost of returning the copies shall be paid by the Muestra de Cine de Lanzarote.

14. The Muestra de Cine de Lanzarote shall take out an insurance policy to cover the risks of robbery, damage and destruction of the copy of the film for the period between its arrival at the festival until its return to the address indicated. The maximum period for making claims is one month from the date of reception.

15. After accepting an invitation to the competition, the films may not be withdrawn from the festival programme.

16. Entering the competition implies full acceptance of the above conditions.
